The buyer agrees that the above described animal is being represented solely as a companion pet.

Buyer agrees to care for the above described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water, and veterinary care. I further agree that said pet shall reside inside my home and shall not be allowed to roam freely.

Buyer agrees the will be primary caregiver for the above described dog.

Buyer agrees to keep the dog immunized and examined annually and current on heartworm preventative, to license the animal in the municipality in which the animal resides, and to keep a collar or harness with identification tags on the animal at all times.

Buyer agrees to retrieve the dog from any public shelter when notified it is there, and to contact Seller immediately if the animal is lost, stolen or dies.

Buyer agrees that the dog will be appropriately contained in a dog safe fenced-in yard or on a leash when outside, never tethered or allowed to roam at large unsupervised. The dog will be housed inside, preferably when no family members are at home in a dog crate or dog x-pen. Dog will sleep inside the house at night, and will not be permitted to be a public nuisance.

Buyer agrees that the seller or seller's representative may visit the dog. If the dog is found to be neglected, ill, living in unsuitable conditions, or otherwise abused that is a default of the sales contract and the dog is to be freely given to back to seller.

Buyer understands that Seller makes no representations or warranties, expressed or implied, about the dog and dog is being sold "as is" including health, temperament, and house manners. The dog will include a vet health check and discloser from the seller of any known health concerns. Seller will in no way be responsible for any and all health problems that may arise, including parasites, internal, external, skeletal, hereditary problems, breed specific problems and any other health related problem not listed above after 72 hours of receipt of the dog.

Buyer understands the dogs is being placed for cost of expenses for spay/neuter and dental. Registrations papers are not offered unless arrangements are made between buyer and seller prior to purchase.

Buyer agrees that they will not sell, give away or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute or any other entity for any reason. If at a later date buyer is unable or unwilling to keep this pet, or is deceased. Buyer agrees or to have the buyers estate to immediately return the dog to seller at no charge or reimbursement of fee's or travel expenses. Non return of the dog or re-homing without written consent of seller will be a default of contract. If the dog is found in a rescue, pound or humane society or any other facility which re-homes pets this will be a default of contract.

Buyer acknowledges that they have read, understood and agreed to the terms of this sales agreement. As of the date of this agreement, buyer will assume full financial responsibility for the above-described animal. Any changes or additional terms to this agreement must be in the form of an Addendum and signed by all parties.

Forbearance or neglect to insist on strict compliance with the terms of this agreement, on the part of either party, shall not be construed as or constitute a waiver thereof. No rights or provisions hereof shall be deemed waived and no breach excused, unless such waiver or consent shall be in writing and signed by the parties hereto.

It is stipulated by and between the buyer(s) and Forevr Papillons herein, that failure to comply with the conditions of this contract shall constitute a default "breach of contract" and liquidated damages in the amount of \$2,000.00 per breached occurrence will be payable to the seller.


Severability; In the event of buyer(s) death the estate will notify the sellers. The dog will be returned to the sellers for re homing in companion home. This agreement shall be binding on the heirs, successors and assigns of each party.

If any provision of the Agreement is or becomes void or unenforceable by force or operation of law, the other provisions shall remain valid and enforceable. This agreement is to be construed under the laws of the state the Seller is currently a resident in. Any action or proceeding brought by any party concerning a dispute arising hereunder shall be brought to court of competent jurisdiction located in the state the Seller owner is resides.

Each party hereby acknowledge that she/he had an opportunity to review this Agreement, including the opportunity to consult with an attorney if she/he so chooses and that this Agreement is entered into knowingly, voluntarily, and an understanding of the terms hereof. No Party has relied on any representation other than the terms of this Agreement.

The Buyer(s) and Sellers, Forevr Papillons, have read and understand this agreement and agree to all parts and portions thereof and consider it as a binding agreement between themselves.
